RESOLUTION 97-2
(Amending Resolutions 89-2, 90-2, 90-4, 92-2, 94-6, 95-2, 95-4) RATES, FEES and CHARGES

BE IT RESOLVED, the Board of Directors of the Westhaven Community Services District establishes the following rates, fees and charges.

1. New Service Connection Fee - (\$4,000 - \$8,000)
2. Non-metered, active service - $\$ 40$ per month per dwelling. An active service is one which is connected to a dwelling as defined in WCSD Ordinance 95-1, Section 210.
3. Non-metered, idle service - $\$ 20$ per month. An idle service is one that is not connected to a dwelling ( Ordinance 95-1, Section 210), but is available to be connected upon activation, or a service that has been disconnected by customer request (Ordinance 95-1, Section 702).
4. Private fire protection - \$20 per month. See WCSD Ordinance 95-1, Section 216.
5. Returned checks - $\$ 10.00$ charge for checks returned due to insufficient funds. See WCSD Ordinance 95-1, Section 602.
6. Reconnection charge - non-payment - \$50. See WCSD Ordinance 95-1, Section 602
7. Reconnection charge - water waste - \$40. See WCSD Ordinance 95-1, Section 802.
8. Transfer Fee - \$50. See WCSD Ordinance 95-1, Section 402.
9. Turn on charge - \$20. See WCSD Ordinance 95-1, Section 702.
10. Emergency Water delivery - See WCSD Resolution 96-2.
