RESOLUTION 98-3 (Amending Resolution 98-2) RATES, FEES and CHARGES

BE IT RESOLVED, the Board of Directors of the Westhaven Community Services District establishes the following rates, fees and charges.

1. System Capacity Charge - \$ 5,895 for new service connections for parcels not in Sections 301 and 302 of WCSD Ordinance 97-3.

WCSD Resolution 98-1.

 Installation Charge - for all service connections shall be equal to the total cost to the WCSD for labor and materials to make the connection, excluding the cost of the meter, but including the cost of mainline extension, if required. WCSD Ordinance 95-1, Sections 404, 405.

- Non-metered, Active Service \$40 per month per dwelling. An active service is one which is connected to a dwelling. WCSD Ordinance 95-1, Section 210.
- Non-metered, Idle Service \$20 per month. An idle service is one which is not connected to a dwelling, but which is available to be connected upon activation. WCSD Ordinance 95-1, Section 210.
- 5. Private Fire Protection \$20 per month. WCSD Ordinance 95-1, Section 216.
- 6. Returned Checks \$10.00 charge for checks returned due to insufficient funds.
- 7. Reconnection Charge after disconnection for non-payment \$50. WCSD Ordinance 95-1, Section 602.
- 8. Reconnection Charge after disconnection for water waste \$40. WCSD Ordinance 95-1, Section 802.
- 9. Transfer Fee \$50. WCSD Ordinance 95-1, Section 402.
- 10. Turn On Charge after disconnection by customer request \$20. WCSD Ordinance 95-1, Section 702.
- 11. Emergency Water Delivery \$40 per delivery. WCSD Ordinance 95-1, Section 1102. WCSD Resolution 96-2.

12. WCSD Labor Charge - \$30 Per hour for labor performed on private property by WCSD personnel at the request of the property owner.
